2000: Assistant US Attorney John Durham uncovers FBI misconduct...Pardon Board reached out to Mueller FBI Director. Judge Ruled FBI Misconduct in the 1965 Teddy Deegan Murder.

2005: John Roberts appointed to Supreme Court. Five months later, Rod Rosenstein appointed to Assistant U.S. Attorney by Bush/Cheney.

2006-2011: ATF Operation Fast and Furious involving Eric Holder and Obama.

reassignment as the next DIA Director.

06/12/2012: Eric Holder (AG 09'-15') found in contempt for hiding documents associated to 2010 Fast & Furious.

07/24/2012: General Flynn DIA Director

07/24/2012: DIA Director James Clapper presented Burgess with the National Intelligence Distinguished Service Medal in recognition of his contributions. Clapper praised Flynn for his work at the Office of the Director of National Intelligence.

08/2012: DIA report published by General Flynn described the Obama Administration about the rise of the Islamic State and the

creation of a caliphate by Syria-based Islamists and Al-Qaeda, but also in identifying that arms shipments in Libya that had gone to Jihadist “Allies” of the U.S. and NATO in the overthrowing of Col. Muammar Qaddafi, were shipped to Syria and became the arsenal that allowed the Islamic State of Iraq and Syria (ISIS), and other jihadist rebels to grow.

09/11/2012: Benghazi, Libya Attack. FBI’s special agent Robyn Gritz details the Obama/Clinton/Petraeus/Mueller stand-down order during the Benghazi attack.

9/12/2012: General Flynn with the DIA releases a report saying the attack was planned 10 days in advance.

2013: McCabe was part of the investigation of the Boston Marathon Bombing. He also secured the arrest of Ahmed Abu Khattala for the involvement in the 2012 Benghazi attack.

06/2013: Former CIA Edward Snowden leaks classified information to the news.

08/2014: General Flynn retired from the U.S.
Army

10/08/2014: The DIA sent General Flynn a
written opinion detailing the ethics
restrictions that would apply to G.F. in

retirement, including his disclosure responsibilities under the Emoluments Clause.

10/2014: General Flynn provided critical intelligence to Defense Secretary Chuck Hagel, prompting Hagel's early October 2014 private email to National Security Advisor Dr.

Susan Rice, blasting the Obama White House's failure to devise a coherent strategy for dealing with Syria.

10/2014: Communication to Rice was made public.

02/2015: Hagel was asked by Obama to resign.

02/2015: Flynn appears on Fox News, gains attention of Republican candidates.

2015: Jill McCabe ran for VA state senate. Received almost \$700k from Terry McAuliffe (Clinton friend), for her campaign.

03/30/2015: Ukraine oligarch Victor Pinchuk who donated a total of \$29M to the Clinton Foundation demands a meeting with Bill Clinton to discuss the Maidan Failure.

04/2015 – 06/2016: Flynn served as an “Advisor” for ACU Strategic Partners, which was promoting a plan to work with Russia to build nuclear reactors in the Middle East.

06/2015: Flynn traveled to Egypt/Israel to represent the Flynn Intel Group along with another company named X-CO Dynamics Inc. led by Alex G. Copson and Rear Admiral Michael W. Hewitt (retired). It was part of an effort promoting a U.S. – Russian partnership to construct nuclear reactor for civilian power needs funded by Saudi Arabia.

07/10/2015: FBI opened a criminal investigation into Midyear Exam on Hillary Clinton's handling of classified information while secretary of state.

07/31/2015: General Michael Flynn was interviewed by Al-Jazeera. Flynn stated that the rise of the Islamic State (ISIS) was the

result of a “Willful decision, by the Obama Admin”.

07/30/2015: McCabe was suddenly promoted to the No. 3 position within the FBI as associate deputy was then transferred to headquarters as well.
